Vending Machines Available on NEXCOM Contract

NEXCOM Ships Store Program has a new vending machine contract with Gekay Sales, Inc. Attached is a brochure that provides information on the new vending machines available for ships stores.

Candy/Snack Machines that are available: The Automatic Products (API) 6000, Ambient Snack (AMS) 35 and 39 machines are currently available.

- The API 6000 machine is 35" wide and has a capacity of 300 to 350 snack items. This machine will fit through a 26" shipboard hatch with the door removed. It can only be purchased as a non-chilled machine. This machine is primarily for small ships (CG, DDG, LPD, LSD).
- The AMS 35 machine is 35" wide and has a capacity of 450 snack items. This machine can be purchased as a chilled or non-chilled machine.
- The AMS 39 machine is 39" wide and has a capacity of 600 snack items and can be purchased as a chilled or non-chilled machine. This machine is for the larger deck ships. (CVN, LHD, LHA)

Drink Vending Machines: The Vendor V521, V621, V721, and V821 are machines currently available.

The V521 machine is 29" wide and can fit through a 26" inch hatch. It is a good fit for any size ship, but mostly for the smaller deck ships. It has a capacity of 196 cans and 91 bottles. Please refer to the attached brochure for the capacity information on the V621, V721, and V821 machines. Those machines are made for larger ships. The V621 machine also fits through the hatch with the door and anti-theft plate removed.

<u>Procurement</u>: NAVSUP Pub 487, Chapter 4, Section III – Purchases Using Ships Store Profits, The following information is provided on the procurement of the machines.

- Requests for machines should be sent to Ms. Felicia Townes, NEXCOM Ships Store Program. Email address: Felicia.Townes@nexweb.org, telephone (757) 502-7470. A pier side or receiving activity address is required for shipment.
- NEXCOM will prepare and forward the purchase order to the vendor. A copy of the purchase order
 will be forwarded to the ship with a cover letter advising the purchase has been placed, charging the
 ship's profits, and that a loan may be requested after receipt of the machines.
- After payment has been made by DFAS, the ship will receive an Abstract Data Report (ADR). The ADR will cite the amount paid and the purchase order number.
- If the ship requires a loan for the machines, a written request must be sent into NEXCOM.
- NAVSUP Pub 487, para 8102 provides detailed information on loan requests.
- NEXCOM will forward written approval for the loan and will provide repayment instructions.
- Upon receipt of the loan, the loan amount will be reported on line C05 (Loans) of the NAVCOMPT 153 as a one-time entry for the period in which it was received.
- Upon receipt of the ADR from DFAS, it will be used by the ship to report the amount on line C18 (Equipment Purchases) of the NAVCOMPT 153.


